

## **Terms and Conditions**

Win one of three free food business Inspections for the 2025/26 financial year.

The Promoter is Tamworth Regional Council (ABN: 52 631 074 450), 437 Peel St, Tamworth NSW 2340.

- 1. Participation in the Promotion constitutes acceptance of these Terms and Conditions of Entry. Entries not complying with these Terms and Conditions of Entry are ineligible and the Promoter reserves its absolute right to disqualify any entrant from the Promotion if any entries do not comply with these Terms and Conditions of Entry.
- 2. Subject to these Terms and Conditions of Entry, entry is open to any food business registered in the Tamworth Local Government Area that uses oil to prepare and/or cook food.
- 3. The competition opens on Thursday, 1 October 2024 at 9am and closes Monday, 30 June 2025 at 5:00pm
- 4. The winners will be drawn by Online Random Generator and winners will be contacted by 5pm Friday 4 July 2025.
- 5. There are **three** individual prizes to be won catering for **one premise** each, consisting of:
  - 1x free Primary food business Inspection that will be completed during the 2025/26
    Financial Year. The value of the inspection will vary according to the category specified for each of the three winning premises.
- 6. Enter by providing the nutritional details of oil being used to prepare and/or cook food to the Promoter by emailing <a href="mailto:tre@tamworth.nsw.gov.au">tre@tamworth.nsw.gov.au</a> by June 30 2025. Once it is confirmed the oil type meets the criteria\* the business will be entered into the draw by the Promoter.
- 7. \*20g per 100ml of oil or less of saturated fat and 1g per 100ml of oil or less of trans fat
- 8. By providing your details to the above listed email to be entered by the Promoter you are deemed to have accepted the Terms and Conditions of the promotion.
- 9. The prize must be taken as offered and cannot be used to cover costs of a re-inspection, for any inspections that have already been completed prior to the 2025/26 FY, cash or any other credits with the Promoter. Prize can only be redeemed for the nominated location listed on the entry.
- 10. Only one entry per premise is allowed.
- 11. The Promoter reserves the right to verify the validity of entries and reserves the right to disqualify any entrant for tampering with the entry process or for submitting an entry that is not in accordance with these Terms and Conditions of Entry.
- 12. The Promoter will provide a letter to each of the three winning premises.
- 13. If this Promotion is not capable of running as planned for any reason beyond the reasonable control of the Promoter (including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures or any other causes beyond the control of the Promoter which
