That in relation to the report "Proposed Motions for the Local Government NSW 2024 Conference", Council authorise the following motions to be submitted to Local Government NSW:

- (i) resourcing the assessment of renewable energy project Development Applications; and
- (ii) ensuring an adequate and enforceable CIV percentage for Renewable Energy VPAs.
- (iii) Implementing a limit on permissible amendments to Development applications for SSD renewable energy projects to a maximum of two iterations before final determination by Planning NSW and the Independent Planning Commission of the project.
- (iv) That the State Government:
 - (a) calls on the Federal Government to restore to Local Government the Federal Assistance Grants to 1% of federal taxation revenue;
 - (b) works with NSW councils to address the systemic funding issues that are giving rise to many councils continuing to seek large increases in general rates by way of Special Rate Variations; and
 - (c) reviews existing sources of funding provided to local government and directs higher levels of funding to ongoing operational support instead of competitive special purpose grants to assist councils to become financially sustainable.
