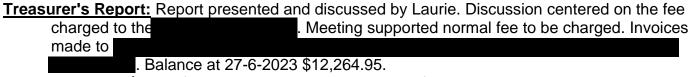
Somerton War Memorial Hall & Recreation Grounds Committee General Meeting Minutes held at the Hall on 27-6-2023

- **3. Light** on Honor Board on the East not working.
- 4. Fan cords need replacing
- 5. Picture of the Queen. Waiting for update of new picture of the King
- **6. Survey community.** Nelly discussed circulating survey to identify the community's interest and expectations of the Hall and Recreation Ground. Nell reported that survey to be circulated on 30-6-23. Boxes will be available and survey monkey.
- **7. Tennis court** still to be repaired.

8. Fund raiser discussed. The meeting propose a Chicken and Prawn night on the 21-10-23. Laurie to discuss with Drue.

ON Going General Business:-

Funding from Empowering Communities for a community activity involving line dancing, BBQ etc. remains a work in progress .This will be organized over three lots of five sessions. Intent is to encourage community gatherings. Events will be free including meal. Plan to purchase a BBQ for the Hall. Yet to confirm a suitable time .

Hire of Chairs. Following discussion, it was decided to charge the following: Light tan chairs - \$1 -Stacker of 4 chairs - \$10 -Bench - \$1- Crockery cupboard - \$10

Fire extinguisher and evacuation plan. None in place at the hall. To follow up with Lisa. Highway signage indicating public amenities i.e. toilet To be followed up with Lisa

Electricity charge. Laurie to follow up with TRC if hall can have a better funding plan. Bill has been forward to **Lisa** to be followed up

Recreation Ground BBQ- The battery is at the BBQ, gas is supplied by? key to the gas bottle cage is with George. Cleaning. **Lisa** to be followed up to request the people who clean the toilets to clean the BBQ

Tennis Courts: Following points discussed:

Community concern of water pooling – George reported that the first court to be resurfaced at cost to TRC. Currently being followed up

Court access discussed as per following points:

- a. If there is competition tennis event TRC would not cover the insurance. Tennis Australia would need to be approached for insurance cover.
- b. Social tennis insurance is covered by TRC
- c. Committee to determine any fee and conditions for access. Yet to be confirmed
- d. Signage needs to be followed up.
- e. Decision of where to locate the key to the tennis courts is yet to be determined

CWA Tree and plaque. Drue reported that 3-4 Chinese Elm trees to be planted on the Western side of the hall. 100 tree project a work in progress by TRC.
