Artisan and Charitable Organisation Stall Terms and Conditions

1. All stall holders must comply with any additional COVID-19 related conditions as relevant in accordance with state health regulations.
2. The **Artisan stall** category is for artists (chalk, spray paint, oil, ink etc), designers and makers whose products are original, of high quality, well presented and made in Australia. Items sold at the stall must be bespoke and made by the artist. Artisan stalls provide an opportunity to 'meet the maker' so we are looking for makers to attend the festival. If you attend and have products for sale that are not made entirely by the stall holder by hand you will be asked to remove these non-handmade items or asked to cease operating entirely.
3. **Charitable organisations** applying for this stall type must be established in the Tamworth Local Government Area (LGA) or include the Tamworth region in its catchment. Any proposed activity at the Tamworth Country Music Festival must also provide direct benefit to the Tamworth region and its community.
4. No onsite parking is permitted. Vehicle access to your site will be restricted to before 9am each day. **All vehicles entering the road closure must display a valid council issued permit.** Vehicles will be permitted to enter the road closure each morning for the purpose of restocking only. More information relating to vehicular access will be provided to successful applicants.
5. No furniture will be provided for stall holders.
6. No water or sewer will be available to sites.
7. All electrical leads used at the site are to be heavy duty and comply with the requirements of WorkCover NSW. WorkCover NSW requires electrical leads to be tested at least annually, and identification tags to be attached. All leads will be inspected by Tamworth Regional Council Compliance prior to the event commencing.
8. The holder of any approval is responsible for the collection and disposal of litter associated with, and in the immediate vicinity of the stall. Adequate bins are to be provided and the garbage contents disposed off at the end of each day. At no time is waste water to be disposed of in the street, gutter or drains. Fines will apply for pollution offences.
9. In the event of an emergency arising by threat of fire or flood, the stall holder shall comply with any direction issued by Council's events or compliance staff or by any member of the SES or emergency services.
10. **Tamworth Regional Council accepts NO responsibility for the security and or any loss or damages incurred to stall holders and street traders during the Tamworth Country Music Festival.**

11. The travel of any pedestrians is not to be impeded.
12. The sale of prohibited, hazardous or dangerous goods is not permitted.
13. Spruiking and microphones are not permitted without prior permission. Pre-recorded messages promoting your stall/business are not permitted.
14. All stallholders at the event shall present and conduct themselves in a manner suitable for a family event. In particular the use of language or images that may be considered offensive by members of the community will not be accepted. If you believe a part of your presence at the event may breach this code of conduct, please discuss it with Tamworth Regional Council before applying.
15. We are looking for stallholders that have something unique and interesting to sell that will add value and interest to the festival for our visitors. We encourage our stall holders to constantly improve and re-evaluate their product.
16. No damage is to be done to the road, footpath or any other council property.
17. The business/organisation must hold a current public liability policy of not less than \$20 million.
18. Should a business or activity choose to operate without the approval of council or outside of their approval, appropriate action could eventuate in accordance with Section 626 and/or Section 627 of the Local Government Act. Provision is made under the legislation to issue an infringement or seize goods offered for sale.
19. Applications fall under the Local Government Act 1993 – Section 68 (1) Part (5) (7).
20. All stallholders and traders indemnify Tamworth Regional Council and its employees and volunteers against any and all liabilities, claims and actions that may eventuate from the establishment, operation and removal of any trading premises (stall) during the 2025 Tamworth Country Music Festival, Friday 17 January to Sunday 26 January 2025.

With consideration to the 2025 Festival dates and the last day being the Sunday 26 January -Monday has been announced as a State Public Holiday. We encourage all stall holders to continue to operate until at least 6pm on the 26 January. Vehicles will not be permitted to enter the road closure to pack down until after 6pm on 26 January (subject to programming).

The Fanzone stage at Fitzroy Street will have artists performing until 6pm so we are encouraging traders to keep operating also, so that the stalls, buskers and Fanzone stage will draw the crowds into the CBD in the afternoon on the last day of the festival.

If you wish to pack down prior to this goods will have to be carried/trolleyed out. There is a loading zone behind the Fanzone Stage in Fitzroy Street that may assist.
