### Festival Road Closure Vehicle Access Permit Terms and Conditions

- There are three permit types with specific access conditions as detailed below:
  - BLUE permit – for access into Kable Avenue (off Bridge Street) for off-street tenant parking;
  - ORANGE permit – for use for deliveries to existing business in the road closure before 9am. Access into Peel Street after 9am may be permitted on a case-by-case basis, for example, emergency repairs or urgent stock delivery.
  - GREEN permit – Tamworth Regional Council and Festival Staff only

**\*NO ACCESS INTO KABLE AVENUE ROAD CLOSURE AFTER 9AM due to high pedestrian levels.**
- Vehicles may **only** enter closed roads at the following designated entry points and times:
  - Kable Avenue and Fitzroy Street at White Street roundabout  
No access into Kable Avenue Road closure from Brisbane/Bridge Street.  
**\* NO ACCESS INTO KABLE AVENUE ROAD CLOSURE (NEAR FITZROY STREET) AFTER 9AM.** Please use the loading zone in Kable Avenue (immediately outside the road closure) and trolley items into the road closure.
  - Peel Street at White Street roundabout  
No access into Peel Street from Brisbane Street.
- Pedestrians have the right of way at all times.
- A speed limit of 10 km/h applies to all closed roads.
- This permit does not preclude the payment of monies for pay parking in non-road closed areas.
- Under no circumstances will any barriers or signs be removed to gain entry to closed roads.
- On-street parking may not exceed 30 minutes and must **ONLY** be while delivering or collecting goods and/or materials related to the permit holder's business.
- No vehicles greater than 7 metres long and restricted to 2 axles.
- The Vehicle Access Permit is not a parking permit. A Vehicular Access Permit allows vehicular access for the purpose of deliveries, emergency repairs or access to off-street tenant parking only.

10. In the event of an emergency arising by threat of fire or flood, the business shall comply with any direction issued by Council's events or compliance staff or by any member of the SES or emergency services.
11. No damage is to be done to the road, footpath or any other council property.
12. The business/organisation must hold a current public liability policy of not less than \$20 million.
13. Applications will be assessed on a case-by-case basis and the applicable permit will be granted subject to its conditions being met at all times by the applicant.
14. All businesses entering the road closure indemnify Tamworth Regional Council and its employees and volunteers against any and all liabilities, claims and actions that may eventuate from enter the festival road closure during the 2025 Tamworth Country Music Festival. Road closures will be in place from Tuesday 14 to Tuesday 28 January 2025.
15. **In the event of not complying with the terms and conditions above, I acknowledge that Council reserves the right to take immediate action to seek compliance with the conditions of approval or that I may be asked to vacate the road closure by Tamworth Regional Council and prohibited from entering the road closure in future.**
